Child care charges

- All children are entitled to 15 hours and parents are not obliged to purchase additional hours or pay lunchtime charges in order to secure their free provision.
- Parents/carers can purchase additional childcare provision where available.
- for those children not accessing the 30 Hours Free Entitlement payment is required in advance for any additional hours over and above the 15 hours per week free entitlement (£20 per Morning or Afternoon)
- For any absences, planned or unplanned (including sickness and holidays) session fees are payable. Any planned absences should be discussed with the School.
