## Nursery provision options for children

Morning nursery	8:50am - 11:50am	Universal free 15 hours provision from the term following a child's third birthday up until they reach compulsory school age
Afternoon nursery	12:30pm - 3.30pm	Universal free 15 hours provision from the term following a child's third birthday up until they reach compulsory school age
All day nursery <b>(Little Hollies)</b>	8:50am - 3:30pm	If you are working parents/carers of 3 and 4 year olds you may be eligible for a further 15 hours free childcare in addition to the existing free 15 hours early education. This is known as the 30 Hour Entitlement See <a href="http://www.childcarechoices.gov.uk">www.childcarechoices.gov.uk</a> for full details regarding the eligibility criteria. * You will need to reapply for this every 3 months.
Fee Paying sessions Morning or Afternoon	8:50am - 11:50am 12:30pm - 3.30pm	If you would like extra sessions, these are available and must be pre-booked a month in advance. The cost for each session is £20 per session (this includes lunchtime supervision)

\* Lunchtime for the all-day nursery children will be from 11:30am until 12:30pm and has a supervision cost of £4 per day. Please provide a packed lunch.

## Little Hollies – 30 Hours Free Childcare Entitlement

Parents may receive eligibility codes before their child is 3 but they can only start claiming their 30 hours place in the term following the child's 3<sup>rd</sup> birthday or the term following the date when the eligibility code was issued (whichever is the later – see table below)

### Child care charges

- All children are entitled to 15 hours and parents are not obliged to purchase additional hours or pay lunchtime charges in order to secure their free provision.
- Parents/carers can purchase additional childcare provision where available.
- For those children not accessing the 30 Hours Free Entitlement, payment is required in advance for any additional hours over and above the 15 hours per week free entitlement (£20 per Morning or Afternoon).
- For any absences, planned or unplanned (including sickness and holidays) session fees are payable. Any planned absences should be discussed with the School.
