### **Frequently Asked Questions**

## 1. What is a multi-academy trust?

A multi-academy trust (MAT) is a charitable trust which is responsible for the operation of more than one academy.

The people in charge of running the Multi-Academy Trust are the company directors, who are responsible for strategic oversight and management. They are also charity trustees and must comply with duties under company law, charity law and education law to promote the success of the academy trust. They determine the policies of the trust, monitor the effectiveness of each academy within the MAT, manage central services where appropriate and report to the Secretary of State.

They work to ensure that each academy is performing to the best of its ability and gets the support it requires.

The role of the Members of the MAT is largely limited to appointing and removing directors and making key decisions such as amendments to the Articles of Association and changing the name of the academy trust. Each of the academies in the trust usually has its own local governing body which has authority delegated to it by the Trust Board.

#### 2. What was our selection process in choosing a MAT?

Governors have undertaken a range of activities over the last 6 months. This includes:

- Undertaking background research so that governors could understand the benefits of academisation, what we would want from a MAT and the characteristics of the school that we would not want to lose.
- Carrying out 'desktop' due diligence activities on each of the chosen MATs based on publicly available information (e.g. websites, performance tables and other Department for Education information, Ofsted reports, financial statements).
- Attending presentations from each MAT and asking a range of questions afterward.
- Shortlisting MATs on the basis of the information gleaned so far. We met with the following MAT's as part of our shortlisting process
  - Archway Learning Trust
  - Aspire Multi-Academy Trust
  - The Redhill Academy
  - Minster Trust for Education
  - Flying High Academy
  - Nova Academy
  - TEAM
- Visiting schools that are members of each of the shortlisted MATs to see the schools in action, speaking

#### 4. Why the Nova Trust?

The Governing Body is keen to belong to a MAT with a clear strategic direction and vision and values similar to our school. It is important that there are opportunities for development at all levels to secure even higher achievements, while still retaining a strong self- identity and autonomy in key areas. The Governors believe on balance that Holly Primary needs would be best served by joining the Nova Trust because of:

- the structured support that will add to and improve what Holly Primary currently has achieved.
- the continuous professional development (CPD) and diverse range of schools, which will enable us to improve in more areas.
- the opportunity to contribute to growing the primary arm.
- the opportunity to contribute to the development of other Trust schools, as a high achieving, outward facing school.
- being listened to leading to the bespoke nature of support at all levels.
- the capacity of the Central Team in all areas (safeguarding, school improvement, HR, Finance, IT)
- many of our children join the Garibaldi school when they leave Year 6. For parents this would allow our community to have the same holiday patterns as well as allowing both schools the opportunity to work more closely together on joint activities. This also includes working closely with the other Nova Trust schools.
- the support and challenge for the local governing body.

#### 5. Whose decision is it whether or not to join a MAT?

The decision to join a MAT and which MAT to join rests with the Governing Body, with approval also being needed from the Regional Director, who acts on behalf of the Secretary of State for Education.

## 6. Has the decision already been made to join a MAT?

No. The Governing Body is currently seeking views from all stakeholders and these views will be considered before any final decision is made.

#### 7. Who will the Governing Body be consulting?

The Governing Body will be consulting with all staff at the school, parents and various other stakeholders, other local schools and other community members.
